**COVID-19 Update:**

We are appreciative of those, especially from our membership, on the front lines of this battle. We are doing our best to support you and get you the resources you need.

Although most Congressional staff are under a "stay at home order," business has simply been modified in Congress and programs are moving and being created to help us. To that end, we wanted to provide you with some quick resources and updates.

**COVID FUNDING**

**CDC**

Funding is available through CDC for the Medical Examiner and Coroner Offices. It will be awarded through the state-based public health preparedness programs (PHEP). This program received \$2.2b in the Coronavirus bill. If you are not participating in this program in your state already you should reach out to your local state preparedness contact and advise them of your COVID-19 response needs. **DOJ**

Funding is available under the Byrne Jag grant program for all forensic science service providers. \$850m additional funds were provided in the Coronavirus bill. This funding (called Coronavirus Emergency Supplemental Fund--CESF)

will allow state and local police departments and jails to meet local needs.

<https://bja.ojp.gov/funding/opportunities/bja-2020-18553> BJA has confirmed to CFSO that all public Forensic Science Service Providers (FSSPs), including Medical Examiners/Coroner Offices, are eligible for this funding through their State Administering Agency. This funding has been allocated to the states in the amounts identified at <https://bja.ojp.gov/program/fy20-cesf-allocations> The funding is to be used for the purchase of personal protective equipment and other needed medical items.

The Consortium of Forensic Science Organizations (CFSO) has been asked to provide the Department of Justice a list of priority equipment needed by the forensic science community. We thank all of you for answering the call to help us produce this document. The final document can be found on the CFSO website <http://www.thecfso.org/COVID Critical List Final.pdf> We are currently working with Congress and the Department of Justice to ensure that the forensic science community is included in all Congressional bills in support of the COVID crisis.

## **OTHER CFSO LEGISLATIVE WORK**

The budget for FY21 continues to move forward and we have provided Congress our needs.

We have begun to work with Congress on an update to the Justice for All Act and Coverdell as they expire in FY21.

The House and Senate have provided the CFSO a draft of their bill regarding the codification of the OSAC and we are in negotiations.

The Senate has begun to review the Migrant bill with the intent of taking it up again.

## **PRESIDENTIAL COMMISSION ON LAW ENFORCEMENT**

The Presidential Commission on Law Enforcement and the Administration of Justice is having telephonic hearings on a number of topics in order to make recommendations to the President this year on needs of the law enforcement community. CFSO Chair Matthew Gamette will be addressing the Commission on April 14<sup>th</sup> to discuss sexual assault and domestic violence related evidence and processing at the forensic laboratory.

## **OPEN SOLICITATIONS**

### **New Solicitation: NIJ National Center on Forensics, Fiscal Year 2020**

With this solicitation, NIJ seeks proposals from qualified applicants to establish and operate the NIJ National Center on Forensics to:

Facilitate a partnership amongst:

1. A full-service State department of forensic science with a medical examiner function;
2. An accredited university of higher education with affiliate medical and law schools; and

3. A statewide district attorneys association.

For the purpose of:

1. Providing medico-legal learning opportunities for medical students to train as deputy medical examiners/coroners in underserved rural areas;
2. Providing forensic science and legal training to district attorneys, judges, and law enforcement; and
3. Developing opportunities, as appropriate, amongst the designated partners to benefit current and future practitioners in the field.

All applications are due by 11:59 p.m. Eastern Time on June 5, 2020.

### **Academic-based Drug Field Testing & Training Initiative**

BJA will select an applicant to establish a pilot project to develop a national training model on current rapid identification technology and scientifically sound field collection and testing methods that can be used when drugs are discovered in the field. To be led by an accredited institution of higher learning, the training should incorporate evidence collection and testing technologies and methods that are reliable within state and local court systems.

### **BJA Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program (COSSAP)**

The Comprehensive Opioid, Stimulant, and Substance Abuse Program (COSSAP) was developed as part of the Comprehensive Addiction and Recovery Act (CARA) legislation. COSSAP's purpose is to provide financial and technical assistance to states, units of local government, and Indian tribal governments to develop, implement, or expand comprehensive efforts to identify, respond to, treat, and support those impacted by illicit opioids, stimulants, and other drugs of abuse. COSSAP aims to reduce the impact of these substances on individuals and communities, including a reduction in the number of overdose fatalities, as well as mitigate the impacts on crime victims by supporting comprehensive, collaborative initiatives. <https://bjaj.org/funding/opportunities/bja-2020-17023>

### **Research and Evaluation for the Testing and Interpretation of Physical Evidence in Publicly Funded Forensic Laboratories, Fiscal Year 2020**

With this solicitation, NIJ seeks proposals for basic or applied research and development projects. An NIJ forensic science research and development grant supports a discrete, specified, circumscribed project that will:

1. Increase the body of knowledge to guide and inform forensic science policy and practice; or

2. Lead to the production of useful material(s), device(s), system(s), or method(s) that have the potential for forensic application.

The intent of this program is to direct the findings of the research and evaluation towards the identification of the most efficient, accurate, reliable, and cost-effective methods for the identification, analysis, and interpretation of physical evidence for criminal justice purposes.

All applications are due by 11:59 p.m. Eastern Time on May 18, 2020.
