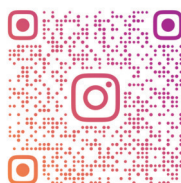

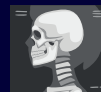
- Perform 200 + forensic autopsies under the mentorship of 17 board-certified forensic pathologists.
