**Job Title of Open Position:** Forensic Pathologist/ Assistant Medical Examiner, Regional Forensic Center, Office of the Medical Examiner for Knox and Anderson Counties; Clinical Assistant Professor, The University of Tennessee Medical Center/Knoxville.

**Qualifications:** American Board of Pathology board certification in AP or AP/CP with the requirement to obtain FP certification within one year of employment; medical licensure in the state of Tennessee; and possession of a Tennessee driver's license.

**Responsibilities:** As an Assistant Medical Examiner the applicant will investigate deaths that fall under the jurisdictions of the Knox County and Anderson County Medical Examiner's Offices. Additional duties include performance of forensic autopsies/examinations for surrounding counties, performing hospital and private autopsies, provide expert testimony in depositions and within the courtroom, provide forensic pathology consultation to medical examiners in the outside counties, participate in teaching pathology residents from the University of Tennessee, and other duties as assigned.

**About the Office and Region:** The Knox County Regional Forensic Center is an 18,000 sq. ft. facility located in downtown Knoxville that has been operational since December of 2014 and has full NAME accreditation. This facility features separate morgue and administration buildings connected by an enclosed breezeway, a gated parking lot for professional staff adjacent to the administration building, a recently installed FOBOS full body scanner, 4 forensic pathologists (including the chief medical examiner), 11 autopsy technicians, 8 ABMDI certified medicolegal death investigators, local forensic anthropology and forensic odontology services, surgical pathology consultation through the University of Tennessee, pediatric pathology consultation through East Tennessee Children's Hospital, and neuropathology consultation through the University of Rochester.

The Knox County Regional Forensic Center houses both the Knox County and the Anderson County Medical Examiner's Offices and offers forensic autopsy consultation to 20 of the surrounding counties in the eastern third of the state of Tennessee, for a catchment area of approximately 1.5 million people. In 2018, the office performed 1054 autopsies and 850 external examinations.

We invite you to consider this opportunity to practice in a county that has been recognized as one of the most livable in the United States. Knox County features a low cost of living, no state income tax or personal property taxes, and a stable economic climate in a beautiful part of the country featuring one of the most visited national parks. Knox County has a diverse and affordable real estate market ranging from modern downtown lofts, to lakefront living, to multi-acre horse farms that are all within a manageable drive to the forensic center.
