The Medical Examiner position is an exempt position with an excellent benefits package including: enrollment in the Arizona State Retirement System, defined benefit plan, 80 hours of vacation leave and 80 hours of sick leave banked upon hire, annual one-week conference leave (expenses paid), accrual of at least four weeks of annual vacation, paid NAME and AAFS membership fees, paid medical licensure renewal and Boards maintenance fees, and free public transit pass.

## About the Position

Medical Examiners in Maricopa County are required by state statute to direct death investigations involving cases in the public interest, including those affecting the criminal justice and public health systems. Medical Examiners will direct medicolegal death investigations, perform postmortem examinations in compliance with the NAME Forensic Autopsy Standards, document findings in narrative reports, take overnight calls from investigation staff, and offer objective consultation and/or court testimony to outside agencies, including criminal court officials and law enforcement. Appointment as a Clinical Assistant Professor with the University of Arizona, College of Medicine-Phoenix is expected and offers access to a full-service medical library.
