# NUECES COUNTY MEDICAL EXAMINER

Responsible for the investigation or supervision of investigation for all types of death. Performs medical-legal postmortem investigations, autopsies and external examinations, orders analytical testing and determines accurate cause and manner of death, including investigation and evaluation of current and anticipated future inquiries occurring within jurisdiction of the Nueces County Medical Examiner in accordance with Article 49.25, Texas Code of Criminal Procedure and with contracted counties.

## MINIMUM REQUIREMENTS:

### Education and Experience:

Graduation from an accredited college of medicine AND a postgraduate training program in pathology AND must have one (1) year of training in forensic pathology at a medical-legal training center.

### Licenses, Registrations, Certifications, or Special Requirements:

Must be licensed to practice as a physician (MD/DO) in the State of Texas. Must have Texas Medical License (MD/DO) issued by the Texas Medical Board.

American Board Certified in anatomical or anatomical/clinical pathology.

American Board Certified in forensic pathology; must have completed or be enrolled in a Forensic Pathology Fellowship if not board certified at the time of hire, must obtain board certification in forensic pathology within two (2) years of employment.

Must have a valid driver's license.
