

Forensic Pathologist for SAN BERNARDINO COUNTY SHERIFF-CORONER DEPARTMENT

This is a full-time position with a salary range of \$207,126-\$278,553 per annum. Salary is commensurate with qualifications and experience. Increased compensation is available for certain additional board certifications. San Bernardino County offers an attractive benefits package which includes: a County-issued take-home vehicle (fuel, maintenance and repairs included), sick leave, vacation leave, annual leave, holiday leave, conference leave. medical and dental coverage, vision care insurance, life insurance, short term disability, expense reimbursement for MOC, pension retirement plan, 457(b) salary savings plan, conference allowance, publication allowance, professional dues & membership allowance, and recruitment relocation asistance.

The forensic pathologist duties and responsibilities include: performing autopsies, providing the determination of the cause and manner of death, timely completion of autopsy reports, and providing expert testimony.

Candidates must possess a valid
Physician's and Surgeon's License issued
by the State of California, possess board
certification in Anatomic Pathology from
the American Board of Pathology, be in, or
have completed, a fellowship in Forensic
Pathology, and possess or be eligible for
certification in Forensic Pathology by the
time of commencing work here. Qualified

candidates once employed must be board certified in Forensic Pathology within two years of the hire date and must maintain board certification throughout the course of employment.

San Bernardino County has a population of over two million and is located east of Los Angeles. It borders Nevada and Arizona and is the largest county in the contiguous United States.

The Coroner Division, which currently includes one chief forensic pathologist, four full-time forensic pathologists and two part-time forensic pathologists, performed approximately 1,600 forensic autopsies in 2019.

Professional sporting venues and entertainment opportunities in San Diego, Los Angeles and Las Vegas are generally within a short drive of the county seat, the city of San Bernardino. Several Southern California beaches are within an hour's drive. Local mountains and deserts provide a variety of recreational locations for rock climbing, hiking, skiing, snowboarding, and various other outdoor activities.

Ontario International Airport services the San Bernardino/Inland Empire area, just 18 miles west of downtown San Bernardino.
